

Terms and conditions

Hannover Messe April 2024

1. General clauses

1. The Hannover Messe activity is a multi-day event organised for members of the study associations Technisch Appèl and Versorium.
2. The activity will take place on twenty-two and twenty-three April two thousand and twenty-four.

2. Terms and conditions

1. Each participant is responsible for his/her luggage with regard to loss, theft and damage.
2. Any kind of damage made to other people's property is the responsibility of the person causing the damage.
3. Each participant will carry a valid ID and health card during the activity.
4. If a participant wishes to go home earlier due to mental or physical reasons, they will have to arrange their own transport. The associated costs will be at their own expense.
5. Every participant shall follow the instructions and directions of the board of the study associations Technisch Appèl and Versorium at all times.
6. The participant agrees that photos and videos will be taken during the Hannover Messe activity and may be posted online.

3. Behaviour

1. If a participant harms others, damages others' belongings, misbehaves or behaves indecently, the study associations Technisch Appèl and Versorium have the right to deny that person further access to the activity.
2. It is strictly forbidden to smoke in the rooms of the accommodation.
3. Bringing and using drugs during the trip and weekend is strictly prohibited. If this is violated, you will be immediately denied from the activity. In addition, the board of the study associations Technisch Appèl and Versorium has the possibility to proceed to a suspension of activities organised by the study associations Technisch Appèl and Versorium. Additional costs will be recovered from the participant. If the use or taking of drugs is suspected, the management of the study associations Technisch Appèl and Versorium may carry out a check.
4. Each participant is responsible for his/her own behaviour during the trip and the weekend.
5. If a participant takes an action that causes additional costs, the participant will have to reimburse those costs themselves.

4. Use of personal data

1. The personal data provided in the survey will be provided to Siemens for personalised tickets to the Hannover Messe fair.
2. The personal data provided in the survey will be provided to YER in exchange for a contribution from the touringcar booking.
3. The names and phone numbers will be used to create a whatsapp group to help the event run smoothly.

4. No personal data will be shared with YER and Siemens after the event.
5. Within 24 hours after the event, all stored personal data will be removed from the Google Forms.

5. Cancellations

1. If, after purchasing a ticket, the participant still decides not to go, the ticket price will not be refunded. However, the participant can resell his ticket, this must be done in consultation with Jort Frankena (0619555333).
2. In exceptional situations due to force majeure, it is possible in consultation with the study associations Technisch Appèl and Versorium not to apply a cancellation fee.

6. Final clauses

1. If a participant does not comply with the above rules, further access to the activity may be denied. The participant is then not entitled to a refund of the own contribution.
2. In all cases that these regulations do not provide for, the study associations Technisch Appèl and Versorium have the right to decide and take action.
3. Acceptance of the general terms and conditions constitutes consent to the use of personal data.
4. Registration for the activity is final when the Terms and Conditions have been agreed and the ticket has been paid.
